

AFFIDAVIT OF PUBLICATION AND POSTING OF NOTICE OF ESTRAY

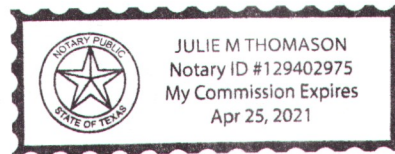
