A tax rate of \$0.730674 per \$100 valuation has been proposed by the governing body of City of Sterling.

PROPOSED TAX RATE \$0.730674 per \$100 NO-NEW-REVENUE TAX RATE \$0.719991 per \$100 VOTER-APPROVAL TAX RATE \$0.808860 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for City of Sterling from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that City of Sterling may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that City of Sterling is not proposing to increase property taxes for the 2023 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON August 28, 2023 AT 6pm AT City Hall, 508 3rd street, Sterling City, Tx, 7695.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, City of Sterling is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of City of Sterling at their offices or by attending the public meeting mentioned above.
