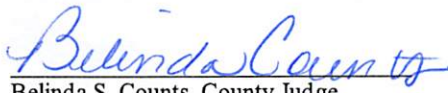


**NOTICE OF OPEN MEETING
OF THE COMMISSIONERS' COURT OF STERLING COUNTY, TEXAS**

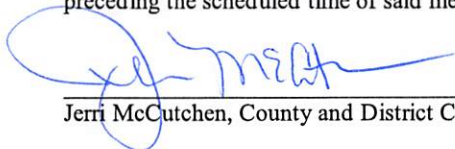
