**Anticipated Improvements:**

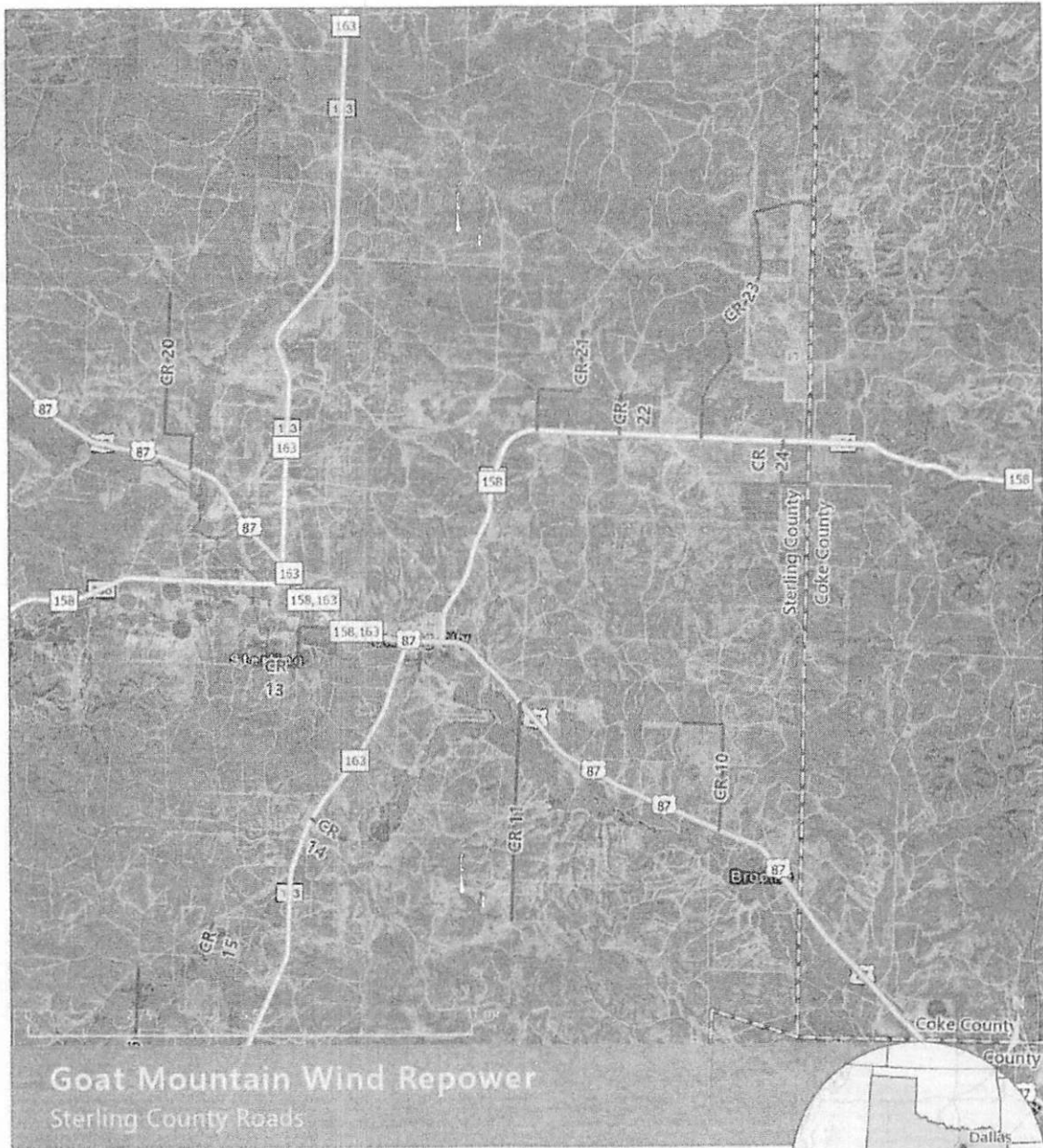
Goat BESS LLC anticipates constructing a 300-megawatt two (2) hour lithium-ion battery storage facility. Additional improvements for the Goat BESS Project will include but are not limited to battery containers, large storage racks, HVAC system, electrical transmission cables, transformers, inverters, and any other equipment necessary to safely store, maintain, and transmit power to the ERCOT electrical grid.

**Estimated Cost of the Improvements:** The best estimate of capital investment of all such improvements subject to the requested tax abatement is \$200,000,000.
